

Verint 2023 Integration Challenge

- 1. Eligibility:** Participation in the Verint 2023 Integration Challenge (“**Challenge**”) is only open to existing Verint partners that have registered for Verint Connect and accepted the [Online Verint Connect Terms](#). The Challenge is an opportunity for existing Verint partners to showcase their creativity and development skills to build integrations with the Verint platform. Integrations submitted to Verint for the Verint 2022 Integration Challenge may not be submitted for this year’s Challenge.
- 2. Participation:** Participation is optional and there are no entry fees to participate in the Challenge. Additionally, participants will not be entitled to compensation from Verint of any kind for participating in the Challenge. By participating in the Challenge, you agree to abide by these official rules and Verint’s decisions, which are fully and unconditionally binding in all respects. Verint reserves the right to refuse, withdraw, or disqualify you at any time at Verint’s sole discretion. By participating in the Challenge, you agree to be bound by all Challenge rules and accept the decisions of Verint as final and binding as it relates to the content of this Challenge.
- 3. Challenge Period and How to get Recognition:** The Challenge begins on November 1, 2022 at 12:01 am ET and ends on May 15, 2023 at 5 pm ET (“**Challenge Period**”). To be eligible for the Challenge, you must comply with all Challenge rules and your entry must be received within the Challenge Period.
- 4. Winner(s):** Verint will determine the number of winner(s), in its sole discretion, based on the number of submissions it receives for the Challenge during the Challenge Period . The winner(s) will be determined after the Challenge Period and will be selected solely by Verint at its sole discretion and judgement based on the participant’s use of Verint tools to integrate with Verint’s products, utility, marketability, and innovation. Winner(s) will be recognized at the Verint Engage 2023 conference (“**Engage23**”) and in online forums (“**Recognition**”). Other than Recognition, winner(s) are not eligible for, or entitled to, any prizes and no other awards will be awarded.
