

## DATA PROCESSING INSTRUCTIONS (“DPI”)

These DPI form part of the Data Processing Agreement ("DPA") entered into between Customer and Verint and is incorporated by reference therein and shall apply only to the processing of Personal Data undertaken by Verint.

In the event of any conflict between the provisions of these DPI and the main body of the DPA, the terms of these DPI shall prevail solely with respect to the processing instructions herein. All capitalized terms herein shall have the meaning assigned within either the Agreement, the DPA or the Order. In the event of any conflict between the provisions of these DPI and the provisions of the Order, the Order shall prevail.
