At Verint, we are committed to fostering a safe, inclusive, and respectful workplace, and to conducting business in an ethical and compliant manner throughout our global operations. In line with this commitment, and in keeping with our core values of integrity, innovation, transparency, humility, and passion, we view respecting and upholding the human rights of our employees, and others whom we work with, as a core responsibility of our organization.

The <u>Verint Code of Conduct</u> sets the ethical standards we expect of our workforce and our ethical culture extends to our supply chain partners. Our <u>Third-Party Code of Conduct</u> further defines our expectations in working with third-parties, including with respect to human rights.

We are proud of the steps we have taken to combat slavery and human trafficking in our supply chain and will continue to work hard to ensure that we maintain these high standards. Our Organisational Structure and Business

Verint Systems UK Limited ("**Verint UK**") is a member of the global Verint group which provides solutions to helps brands increase customer experience ("**CX**") automation across the enterprise so they can elevate the customer experience and reduce their operating cost. Verint's CX automation solutions are sold predominantly through the Verint cloud platform.

Our Supply Chains

Due to the nature of our business, we have a diverse supply chain which includes a range of vendors globally, including professional service organisations. Verint UK does not rely on a significant amount of manufacturing sector vendors as part of its supply chain.

Our Policies on Slavery and Human Trafficking

Verint UK is committed to ensuring that there is no modern slavery or human trafficking in our business or in our supply chain. The <u>Verint Code of Conduct</u> and <u>Third Party Code of Conduct</u> reflect our commitment to acting ethically and with integrity in all our business relationships and to implementing appropriate diligence and controls.

Due Diligence Processes for Slavery and Human Trafficking

As part of our initiative to identify and mitigate risk we assess our vendors and seek their commitment that they have reviewed, understood, and will adhere to our <u>Third Party Code of Conduct</u> or equivalent policies and controls of their own.

We have in place procedures to:

 Identify and assess potential risk areas in our supply chains relevant to the Modern Slavery requirements.

Supplier Adherence to Our Values

Verint has a zero tolerance attitude on slavery and human trafficking. All new vendors complete an onboarding process which requires, among other things, that they agree to comply with applicable law as well as our Third Party Code of Conduct or equivalent policies and controls of their own.

We have a multi-disciplinary Modern Slavery compliance team, which includes the following functions:

- Human Resources
- Procurement
- Legal & Compliance

Our Effectiveness in Combating Slavery and Human Trafficking

We intend to continue to monitor and build upon the vendor processes we have already established.
